Earlier this year, we heard from long-time camper Taylor about her summers at Flying Horse Farms. As a child diagnosed with juvenile arthritis, she'd never met anyone else like her – or someone who wanted to understand a kid like her. Until...she experienced the magic of camp at Flying Horse Farms.

She met and befriended kids who knew what it was like to live with a serious illness. And because she felt surrounded and welcomed by people who understood her, she participated in activities like swimming and archery without feeling the pressure "to measure up or keep up." Taylor's camp experience was transformational.

And she's not the only one.

When surveyed, 100% of parents, year over year, consistently report feeling their child had an improved self-image after attending Flying Horse Farms in 2021.

I love what Taylor shared, and as you read the stories in this Impact Report, one of the things that will stand out is the power of people coming together.

Children and families have been coming together at Flying Horse Farms for over a decade to find a community that provides a sense of belonging and holistic healing. Once they've entered through the Hole in The Wall, they feel at home, knowing the weight of living with a serious illness will be understood by all those at camp.

Flying Horse Farms affords families necessary time to exhale and reconnect while campers discover new strengths, learn new skills, and experience joy that results in reduced anxiety, strengthened family connections, and increased confidence that lasts long after closing



campfire. This is the healing effect camp provides from a life of living with daily stress, trauma, and uncertainty.

As a regional asset in holistic healing, Flying Horse Farms is focused on enhancing and expanding opportunities to serve more families than ever before.

This means leaning into trauma informed care and building on our proven mission delivery model, scaling to a year-round, multi-pronged approach that addresses social determinants of health and the role we can play in abating the mental health epidemic facing youth today.

We are all in on the belief that through partnering with healthcare providers, colleges and universities, and mission-aligned organizations we will make it possible for more children with serious illnesses to heal, grow, and thrive.

Thank you to our donors, volunteers, medical partners, supporters, and friends who come together to magnify the impact of camp and are the spark that has ignited our bold vision for what more is yet to come for Flying Horse Farms, this place we call camp. This place we call home.

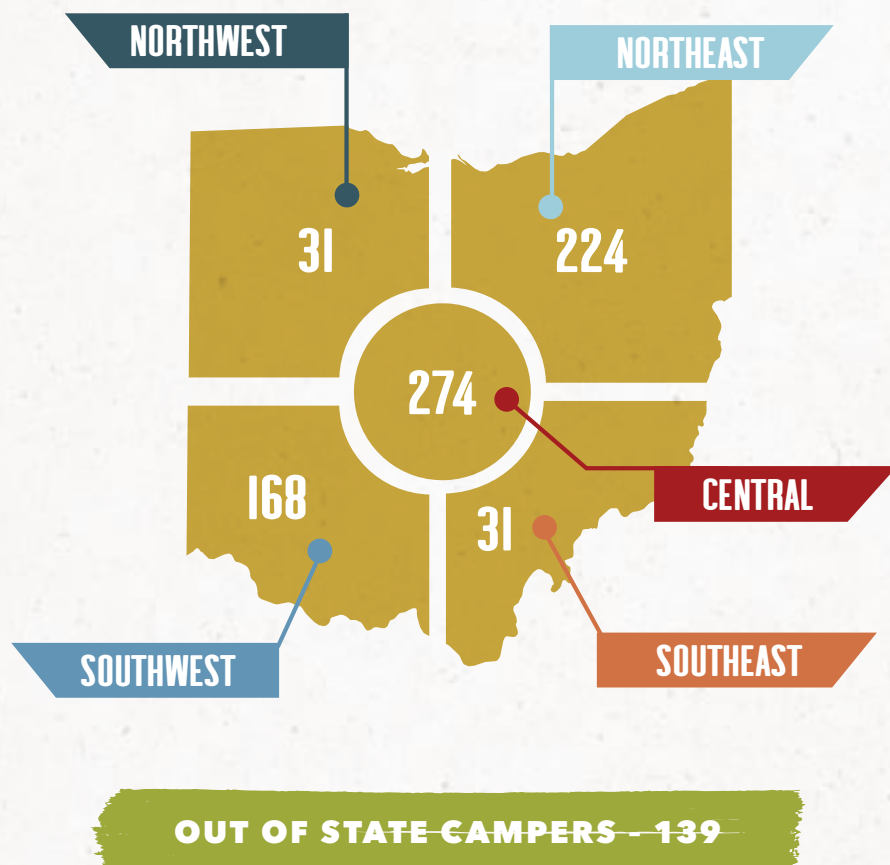

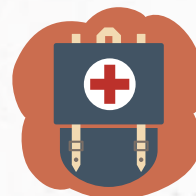
Camper SNAPSHOT



In 2021, Flying Horse Farms welcomed 90 families for Family Camp and some much needed respite, joy, and connection. FHF also hosted its first camper-only residential camp program since 2019 when Trailblazer camp, our adolescent and young adult program, returned in November. Children throughout Ohio and beyond also found their way to camp virtually, participating in online Camp-in-a-Box activities, campfires, and cabin chats. In total, 867 children laughed, danced, and felt that kind of belonging and joy that can only come from camp.

After first hearing about Flying Horse
Farms from other generous donors in
Northeast Ohio, the foundation began
supporting camp in 2014.

"From our first visit to the camp, we were
impressed with the facilities, amenities,
and programs. What resonated with us
most, however, was the caring staff and
volunteers," says Pam Eichenauer, The
Kelvin & Eleanor Smith Foundation Grants
Manager. "It was clear that campers and
their families were at the heart of every
detail of planning for each camp session."

Out of an abundance of caution, Flying
Horse Farms elected to postpone
residential camp opportunities during the
height of the pandemic and offer virtual
options instead. The change in the camp
landscape didn't deter allies like The
Kelvin & Eleanor Smith Foundation, who
doubled their annual gift of support to
make it possible for children who were
managing their complex healthcare
needs along with increased isolation
caused by the pandemic.

"We were delighted that Flying Horse
Farms rose to the occasion and found
unique ways to reach campers when
in-person experiences were not a safe
option," Pam says. "Camp-in-a-Box
allowed kids and their families to enjoy
fun experiences at home, and Fireside
Chats allowed caregivers to connect
virtually for wellness and support."

Pam and the foundation board agree this
sort of inventive thinking aligns with their
mission of supporting nonprofits that
exemplify strong leadership and creativity.

"We're grateful for the steadfast
backing of The Kelvin & Eleanor Smith
Foundation," says Nichole Dunn, Flying
Horse Farms CEO. "It's because of the
confidence partners like this have in
us that we've been able to grow camp
services and expand our mission every
year, even during the pandemic."

In the future, The Smith Foundation plans to
continue investing in nonprofits that make
a positive difference in people's lives and
in the community at large. We're grateful

While 2021 was difficult for many on so many levels, our family was blessed with opportunities to attend a Flying Horse Farms Family camp, participate in "Camp-in-a-Box," and volunteer at Light Up Camp—experiences that provided a lot of light and love in an otherwise challenging year!

Diagnosed with a rare medical condition at age 4, our son, Spencer, is now 14 and has spent a lot of time managing diet, medications, and questions from others.

In early February 2021, we learned about Flying Horse Farms and Spencer's eligibility to participate. While Flying Horse Farms elected not to host residential camping in 2021 due to the pandemic, we were able to attend a Family Camp and knew we would enjoy having time to unwind and have fun

together while remaining safe. We knew all of Spencer's medical needs would be addressed while we participated in camp activities like fishing, archery, crafts, and more. We particularly enjoyed the unique events like opening and closing campfire, dancing after meals, and even proudly telling detective jokes in trench coats and fedoras as part of camp closing ceremonies!

As 2021 progressed, we participated in Camp-in-a-Box, which allowed Spencer to gather online with other campers and do things like make slime and build airplanes! It was in one of those sessions that he learned about identifying his own and others' personal pronouns as a way of showing curiosity and respect for gender identity. We love the inclusivity that Flying Horse Farms shows to all people!



I got the opportunity to volunteer at another Family Camp and thoroughly enjoyed seeing other families get the gift of relaxation and relief that was so freely given to us. Getting to know many of the campers was a huge gift. I found commonalities with other families, and being able to offer them some respite felt really good for someone who can relate.

Finally, in December, we came back to Flying Horse Farms as a family to volunteer for Light-up Camp! Spencer was old enough to volunteer, and the joy I saw on his face as he had the opportunity to lead cars into the camp for the light show was heartwarming. He loved being able to give back to Flying Horse Farms in a fun way!

We learned so much from our experiences at Flying Horse Farms this year. As a new camp family, we were touched by the open-hearted giving and simple fun that Flying Horse Farms provides for its families, its volunteers, and its donors. Spencer is excited to participate in a full residential camp soon, and we look forward to returning to Family Camp as well! We have thought about it often this winter as we've curled up in the cozy quilts that were gifted to us when we visited.

What do you think people who haven't been to Flying Horse Farms should know?

How did you first hear of Flying Horse Farms?

We first learned about Flying Horse Farms through a friend who had been involved with camp since the beginning. We immediately knew we had to get involved. After learning more, Nate joined the Board of Directors, serving on both the Development and the Facilities Committees. It was during his time on the Facilities Committee when we first made the decision to donate a vehicle. Camp meant so much to us, we knew it could be used for camper transportation, camp outreach, and more.

Why do you support Flying Horse Farms?

We support camp because we know how important the experiences are to the children and families who call Flying Horse Farms home. Camp is often the only place where they can safely spend the night away from home and meet other kids or families with similar health needs. After the increased isolation and stress they've experienced over the past few years, they need camp more than ever.

What is your favorite part about being involved with Flying Horse Farms?

Our favorite part of camp is seeing children's happy faces when they have a chance to be a "happy camper." Knowing the support we provide goes toward helping children with serious illnesses, and their families, is absolutely a life-affirming experience.

A LEGACY OF GIVING

Even though he never attended Flying Horse Farms, Scott Harman was “camp spirit,” personified.

“He was a fun-loving kid,” shares his mother, Jeanne Harman, “The kind of guy who would see someone struggling and run alongside them and cheer them on.”

Scott loved sports, music, and being around people. “He made so many connections,” says Jeanne. “People were really important to him. It was part of his personality.”

After Scott passed away suddenly from a heart condition in 2012 at the age of 20, his family decided to channel their grief into something that would honor him — and help others at the same time.

Beginning in 2013, Scott's family has held annual golf and dinner events, raising money to support causes and organizations that had a connection to Scott. Along the way, they established the Scott Harman Foundation as a component fund of the Dayton Foundation.

When Dr. Joe Ross, Scott's doctor and long-time camp supporter, introduced Jeanne to Flying Horse Farms a few years back, she made the trip to camp for a tour. She fell in love with Flying Horse Farms and its mission and made the decision to give all proceeds from the Scott Harman Memorial Golf Outing to Flying Horse Farms.

Funds raised from the Harman Memorial Golf Outing support camp programming for children who live with many different illnesses, including heart conditions.

“People that attend the event love that everything goes to camp,” says Jeanne. “They're very pleased with the choice. Flying Horse Farms touches a lot of people from a lot of different ages — just like Scotty did.”

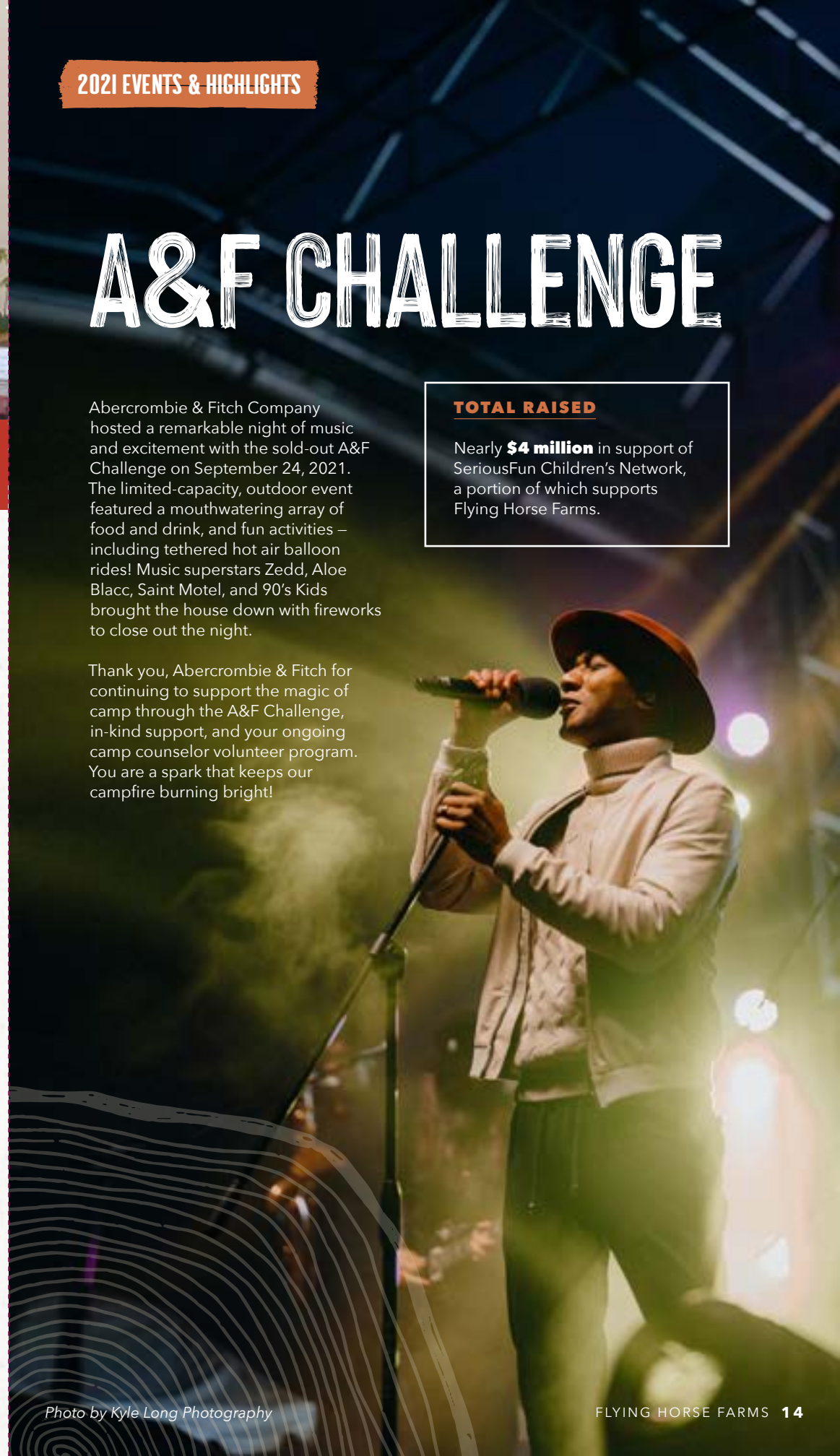

Giving back THROUGH GRATITUDE

Flying Horse Farms has always been, in Allie Myers' words, her "happy place." She first came to camp after she was diagnosed with juvenile arthritis at age 10.

"I felt like taking care of my own health was my whole life at that point," Allie shared. "And then to just be away from that for a week at camp and forget about it and just be a kid. It was really nice."

Allie has seven years-worth of memories at Flying Horse Farms as both a camper and a Ranger, including hanging out with friends and competing in the Color Olympics.

Last year, during her senior year of high school, Allie was asked to complete a capstone project and thought of her times at camp. How could she help ensure more kids could create memories like she did? After weighing many options, Allie decided to design and produce "gratitude journals" to sell and then donate the proceeds to Flying Horse Farms.

"I wanted to give back because they've given so much to me, and just made me feel so welcome over the years," Allie says. "I want to be able to make sure other people can experience that, too."

What happened with her gratitude journals surprised her.

"I was expecting to only sell 50 – that's how much we bought originally – and we sold 650."

Allie has raised over \$4,000 for Flying Horse Farms through her capstone project.

"It's an honor to accept a gift from any camper," said Dani Wilkinson, Flying Horse Farms Chief Mission Officer and Camp Director. "Especially in a circumstance like this in which Allie was able to take some of the skills she learned at camp to support other children who will come and find the same sense of belonging, strength, and healing as she did. We're so proud of Allie and the young leader she has become."

Here at Flying Horse Farms, we think the world of Allie and are so proud of her. The generous spirit of campers like her, who are excited to give back even when they've faced so many challenges themselves, inspires us every day.



A LIFETIME OF IMPACT

His most enduring creation is HappyTimes Woodshop, which opened to campers in 2019. George led fundraising efforts for the new facility with Barb and Phil Derrow and built a space where children could feel the pride of creating birdhouses, cutting boards, picture frames, and take home the confidence that came with it.



GRANDPA

Bill Kreeger, known as "Grandpa" to many at Flying Horse Farms, was a welcoming face to campers nearly every arrival day at camp for the past decade. His steady, assured hands also guided many an arrow to a bullseye and built a stalwart crew of volunteers known as the "Over the Hill Gang" who now lovingly tends to every piece of the camp property. He's a legend, along with his wife "Princess." This year, to honor his legacy, the "Campers First" volunteer award has been renamed the "Bill Kreeger Campers First Award."

THE BACKYARD FUNDRAISER *that turned into* SOMETHING MORE

The first Berkshire Triathlon was held in Columbus 12 years ago, ending with a party in Samir and Amalee Dahman's backyard.

"My husband came to me and said, 'Let's host a charity event.'" Amalee says. "His idea was to do an unofficial triathlon and then afterwards, host a barbecue for friends. Whatever money people could give, we'd donate to a good cause." She laughs. "I said, 'What are you talking about? We can't just do that.'"

Eventually, Samir convinced her, and they had about 40 participants for the inaugural Berkshire Triathlon that year. The event has since grown and evolved with hundreds of participants raising more than \$168,000 for children with serious illnesses to date and the festivities growing beyond their backyard. Flying Horse Farms is honored to be a beneficiary of this remarkable event.

"We feel like we're really helping give children who go to camp an experience,"



Amalee says. "It's rewarding to know we can provide the opportunity for children to have a week where they don't have to worry about their illness."

Just like camp, the Berkshire Triathlon is all about fun. The Dahmans call it a "TRY-athlon" so there is no pressure on participants. There's no tracking chip and no time being recorded.

Flying Horse Farms counselors and staff have served as race volunteers the past few years, adding a dose of camp spirit to the event. Dressed in costumes, staff have also hosted one of the most exciting portions of the day, the Kids' 1-Mile Fun Run. Campers and parents also speak to the crowd about what camp means to them.

"They have such a beautiful energy about them and get everyone excited," Amalee adds. "They help everyone understand the 'why' behind the event."

"My dream is for my children to take over the event when they're adults, and let it be a legacy of giving we pass down to them, and they'll pass down to their families."
