ARE FAMILY CAMP WEEKENDS DIAGNOSIS SPECIFIC?

Family Camp sessions are open to qualifying diagnoses.

DOES CAMP PROVIDE CHILDCARE FOR YOUNGER SIBLINGS

Your family will be accompanied by a Sidekick throughout the weekend, and you can think of them as an extension of your family! They will be with you during activities, mealtimes, full-group programming, etc. and are here to support your family!

Please note: Children 3 and under must be always accompanied by a caregiver. Children 4 and up are welcome to explore camp with their sidekick while following FHF's ratio and supervision guidelines. All campers under the age of 18 must be always accompanied by an adult

WHAT IS THE CABIN LAYOUT? IS MY FAMILY ABLE TO HAVE A SOLO CABIN?

Each cabin at camp is set up to hold two families comfortably, with plenty of beds, private bathrooms for each family, and a semi-private room for caregivers attached. If you have any questions or concerns about sharing a cabin with another family, please reach out to campers@flyinghorsefarms.org

WHEN WILL WE FIND OUT ABOUT FAMILY CAMP PLACEMENTS?

Placements are determined by the FHF team and consider multiple factors. Once placements are determined, every family will receive a notification about their status. For Spring Family Camp assignments, you will be notified in late March. For Fall Family Camp assignments, you will be notified by early September. ARE WE ABLE TO BRING OUR OWN FOOD TO FAMILY CAMP?

Our Food Services Team is dedicated to navigating all camper and family's dietary needs to ensure everyone is fully accommodated while at camp. With that said, we understand some campers have safe foods that come from home, and you are more than welcome to keep food in the cabin with your family. As an allergy conscious facility, we do require any snacks you bring meet those requirements and do not contain nuts or shellfish.

WHAT IF OUR CAMPER IS NOT ABLE TO RECEIVE A SPECIFIC VACCINE REQUIRED TO ATTEND?

If your camper is unable to receive a vaccine for a medical reason, please contact our Admissions Team at campers@flyinghorsefarms.org - they will send a Medical Contraindication form to you for your Medical Provider to fill out and return to us either by:

Once our team receives the Medical Contraindication form, it will be reviewed by the Immunization Exemption Committee, and they will determine eligibility for camp programs.

HOW DO I APPLY?

Click [here](#) to start your/ your family's camp application. To start, create a new account or use your previously used log-in if you are a returning family. FHF considers applications throughout the camp season. Submitting all forms by our priority paperwork deadline ensures our team has adequate time to review your application. Applications received after the priority deadline may be placed onto our wait list. Priority deadlines for the 2025 season are:

- Spring Family Camps: March 3, 2024
- Summer Family Camp: June 30, 2025
- Fall Family Camps: August 11, 2024

All required forms can be found in "Forms" page on Campsite. To be considered for camp, applicants must complete an application for each family member wishing to attend and submit all required paperwork. WHEN WILL I FIND OUT IF MY KID/FAMILY HAS BEEN ACCEPTED TO COME TO CAMP?
